#### Tis the Season to Shop and Compare



As most of us on Medicare know, this is the time of the year when we receive those annoying phone calls and mailings trying to get us to join a Medicare Advantage program (Medicare Part C) that will "give us the BEST benefits at little or no cost to us."

Is there anyone who really believes that an insurance company that exists to make a profit for the owners/shareholders of the company wants to provide you with excellent coverage for little to no cost? Why would these companies hire people to call us, spend money mailing us literature, or hire actors and former athletes to make commercials to influence us to purchase their product?

According to the Kaiser Family Foundation (KFF), the gross profit margin per enrollee in the Medicare Advantage market for 2023 was \$1,982. This report highlights that older adults represent the largest group of healthcare consumers, generating significant revenue for insurance companies. The top five health insurance companies offering Medicare Advantage products in 2023 reported a combined profit of \$44.5 billion!

Additionally, AARP states that people with Medicare will have access to an average of 15 Part D plans and 34 Medicare Advantage plans that include prescription drug coverage next year. With so many choices, along with confusing terminology and high-pressure sales tactics, it's no wonder that navigating the best plan can be frustrating.

In September, President-elect Trump mentioned that he has a "concept of a plan" for improving medical care. Hopefully, this concept addresses the findings from a study published in 2023 in JAMA Network Open, a monthly open-access medical journal published by the American Medical Association, revealing that 20 percent of older adults do not take their medications as prescribed due to cost. This plan should prevent seniors from falling into bankruptcy while trying to cover their medical expenses. It should ensure that seniors receive the prescriptions their doctors recommend rather than being limited to those that their insurance will cover. Furthermore, it should allow seniors to seek treatment at facilities of their choice rather than restricting them to those within the insurance carrier's network.

With one party poised to gain control of the government's Executive and Legislative branches, it will be evident how committed they are to addressing these critical and often life-threatening issues, as well as their proposed solutions. In the meantime, you may be able to save money or find better coverage by shopping around and comparing different Medicare Advantage or supplemental programs to cover the costs not paid by traditional Medicare.

## Retirees Have Reason to Celebrate: A Deeper Look at USW & SOAR Members' Impact on the 2024 Election



Throughout 2024, mainly since Labor Day, USW and SOAR members worked tirelessly to ensure our core values were on voter's minds as they prepared to cast their ballots.

In our conversations with fellow union members, our families and the community, we spoke passionately about collective bargaining, workplace safety and health, job security, domestic economic issues, health care, and retirement security.

We also did everything in our power to remind union voters of the following:

- Our union's endorsements are a recognition of shared values. As with any election, the USW only endorsed candidates who clearly demonstrated their support for protecting and strengthening unions. If a candidate was anti-union, they didn't get our support. It's that simple.
- Who you vote for is a personal decision, and the central role of our member-to-member voter mobilization effort is to ensure union members and our families know which candidates share our values and those who don't.

By midnight on November 5, it was clear that our union's endorsed candidate for President, Kamala Harris, would not be victorious.

However, we've been thankful for the number of USW-backed candidates who have prevailed as votes continue to be counted in the battleground states, including:

- Arizona: Voters elected Ruben Gallego to the United States Senate;
- Michigan: Voters opted to secure a labor-friendly majority in the state supreme court with the election of Kyra Harris Boulden and Kimberly Ann Thomas. Additionally, our friend Elissa Slotkin prevailed in her campaign for the U.S. Senate, along with labor-friendly candidates in competitive Congressional Districts, including Hillary Scholten (MI-3), Kristen McDonald Rivet (MI-8), Haley Stevens (MI-11), and Shri Thanedar (MI-13);
- North Carolina: Union ally Josh Stein was elected Governor;
- Ohio: Voters reelected incumbent labor allies, including Greg Landsman (OH-1), Joyce Beatty (OH-3), Shontel Brown (OH-11) and Emilia Sykes (OH-13). We are still awaiting the outcome in Ohio's 9th Congressional District, where our longtime friend, Marcy Kaptur, is currently leading;
- **Nevada:** Our efforts were key in securing reelection for U.S. Senator Jacky Rosen while also assuring victories for Dina Titus (CD-1), Susie Lee (CD-2) and Steven Horsford (CD-4);



• **Pennsylvania:** Voters opted to keep a labor-friendly majority in the state house while also delivering victories for union-endorsed candidates, including Chrissy Houlihan (CD-6), Chris Deluzio (CD-17), Nick Pisciottano (SD-45), Rob Matzie (HD-16) and Arvind Venkat (HD-30); and

• **Wisconsin:** One of our closest allies in the U.S. Senate, Tammy Baldwin, prevailed in her reelection campaign while labor-friendly allies made inroads in the newly redistricted state legislature.

Outside of these battleground states, our union is celebrating a growing list of victories for pro-labor candidates in local, state and federal elections, including those who won in competitive elections for the U.S. House of Representatives, including Frank Mrvan (IN-1), Nikki Budzinski (IL-13), and Eric Sorenson (IL-17).

This is far from a complete list of all the victories our efforts helped secure in the 2024 elections. But, we wanted to highlight these wins because we are proud of the tireless work of our USW and SOAR members who, against all odds, helped ensure an election outcome that will mean retired and working people will continue to be well-represented in local, state and federal government.

Rest up during the holidays! And get ready for our ongoing efforts to continue this vital work in 2025.

#### **USW's Official Statement Regarding the 2024 Election Outcomes**

#### **November 5, 2024**



Pittsburgh – United Steelworkers (USW) International President David McCall issued the following statement in response to the November 5 election:

The American people have spoken, and the USW will respect and honor the electoral process and the Constitution of the United States.

Unfortunately, one of the great tragedies of this grueling election season has been the way in which key figures sought to divide working

Americans against each other, be it along the lines of gender, race, occupation or country of origin. Now more than ever, Americans must come together for the benefit of our representative democracy.

Thanks to the Biden-Harris administration we have made huge strides on behalf of workers, standing up for retirement security, making health care more affordable, overseeing historic investments in our critical infrastructure and instituting a long-needed industrial policy to build out our manufacturing base.

We must defend these historic victories, and will not rest until they reach their full potential. We will work tirelessly until all workers have fair wages and strong benefits, until everyone can come home safely from their jobs, until our supply chains are robust and resilient enough that we can withstand the next global disruption.

Our union is intent on moving forward in a way that heals our divides rather than inflames them, and the USW will do its best to work with the Trump administration in the best interests of our members and their families.

But we will not allow the billionaire class to run roughshod over workers' rights, outsource jobs and call it fair trade or institute tax policies that mortgage our collective future for the benefit of the already wealthy few.


The holiday season is upon us and for the 11th straight year the Alliance for American Manufacturing (AAM) is here to help you

#### Looking Ahead to 2025: Defending the Benefits We Earned

With the 2024 elections now behind us, it is time to think about where we go from here. And that includes continuing to work with our allies on Capitol Hill to defend against all attacks on Social Security and Medicare, allow Medicare to negotiate lower prices for more drugs, and keep the cap on insulin prices at \$35 per month for Medicare beneficiaries.

An analysis published by the Committee for a Responsible Federal Budget warns that the impact of Donald Trump's campaign plan to eliminate taxes on Social Security benefits, tips and overtime, as well as enact mass deportations and steep tariffs, would have a devastating effect on Social Security. The Committee's research found that it will shave up to three years off the Social Security program's projected solvency – advancing the insolvency date from 2034 to as early as 2031.

We must not let that happen.

In addition, the Heritage Foundation published a 900-page policy blueprint entitled "Mandate for Leadership, the Conservative Promise, Project 2025," that was designed to be the roadmap for a second Trump Administration.

If implemented, the changes would include dramatic cuts to Medicare. The plan would make Medicare Advantage the default enrollment option for people who are newly eligible for Medicare; when Medicare Advantage was created, insurance corporations argued that they could deliver more benefits to consumers at a lower cost to the government, but this has not happened.

The blueprint is especially troubling because there have also been other signals that seniors' earned benefits are in danger with a second Trump term. The Republican Study Committee, a group of more than 170 House GOP lawmakers – including many allies of Trump – released a budget plan in March that calls for over \$1.5 trillion in cuts to Social Security, including an increase in the retirement age to 69 and cutting disability benefits.

Please continue to help us in our efforts in 2025 as we defend our hard earned benefits. These benefits are worth defending, and we will call on you when they are at risk.

By working together, I am confident we can enjoy a Happy New Year!

### Retirees Applaud House of Representatives' Passage of Social Security Fairness Act

November 12, 2024

The following statement was issued by Richard Fiesta, Executive Director of the Alliance for Retired Americans, regarding House passage of the Social Security Fairness Act, H.R. 82

Tonight the U.S. House of Representatives voted to correct a serious injustice involving Social Security benefits that has been a problem for decades. Retirees congratulate lawmakers on taking this much needed action.

The Government Pension Offset (GPO) and Windfall Elimination Provision (WEP) <u>unfairly reduce</u> Social Security benefits for public sector retirees who receive a public pension – or the spouse or survivor of a Social Security beneficiary – who worked in a job not covered by the Social Security program.

By passing H.R. 82, the Social Security Fairness Act, the House voted to fix two unfair provisions that are currently being used to calculate benefits.

The GPO and WEP cause an unnecessary hardship for 2.8 million retired and disabled Americans. It is fundamentally unjust that public employees who earned Social Security credits and benefits through non-government employment cannot receive the full benefits from their work.

Many Alliance members and other retirees are seeing their Social Security benefits reduced by hundreds of dollars a month. The economic harm to their quality of life cannot be overstated.

The House took the first step in fixing these unreasonable provisions. Now we need the U.S. Senate to follow suit and pass the Social Security Fairness Act as soon as possible.

#### **How To Prevent Falls and Their Sometimes Horrific Consequences**

According to the <u>National Institutes of Health (NIH)</u>, more than one in four people over 65 fall each year, and around three million end up in the emergency room or as a hospital inpatient. Falls are increasing, even though they are preventable. Falls are also costly. In the period between 2016 and 2018, the <u>average annual cost of falls</u> among older adults was \$80 billion.

For older adults, the consequences of a fall can be particularly horrific, restricting people's activities, if not robbing them of their independence. According to the CDC, <u>falls are the leading cause of injury and injury death</u> among people 65 and older.

#### How to prevent falls?

SOUR

- 1. Talk to your doctor about the side effects of the medications you're taking, both prescription and overthe-counter drugs. Some medicines can make you dizzy and more prone to falls.
- 2. Make your home safer. Remove any loose rugs or tack them to the floor. Install grab bars in the bathroom. Use night lights.
- 3. Stand up slowly after sitting to avoid light-headedness.
- 4. Have your eyesight and hearing checked each year.
- 5. Use a cane or walker for stability.
- 6. Do balance and strength exercises.

#### Here are five exercises to improve balance that the NIH recommends:

- 1. **Standing on one foot.** Place a chair in front of you and hold on to it with one hand. Then raise one leg and hold it up for 10 seconds. Then do it again with the other leg. Repeat this exercise three times on each leg.
- 2. **Walking heel to toe.** Place the heel of one foot in front of the toe of the other. Now take a step with your back foot and move it so that the heel is just touching the toe of your other foot. Repeat 18 more times. Focus your gaze on a spot in front of you to steady yourself. You can also hold your arms out on either side of you for balance.
- 3. **Back leg raises.** Place a chair in front of you and hold on to it with one hand. Breathe in. Lift one leg back as you breathe out. Keep the leg you stand on slightly bent. Repeat 10-15 times on each leg.
- 4. **Side leg raises.** Place a chair in front of you and hold on to it with one hand. Breathe in. Lift one leg to the side as you breathe out. Keep the leg you stand on slightly bent. Repeat 10-15 times on each leg.
- 5. **Balance walk.** Walk in a straight line for 20 steps lifting one knee up and then the other. You can hold your arms out on either side of you for balance. You can also focus your gaze on a spot in front of you.

The "Medicare & You" handbook is your official guide to Medicare. An updated printed handbook was mailed to all Medicare households in late September, just in time for Medicare's annual enrollment period, which runs from October 15 – December 7. You can also download a copy anytime, or access it electronically for the most updated information available at Medicare.gov

Keep your handbook as a reference. It has important information about:

- Medicare benefits, costs, rights and protections
- Health and drug plans
- Answers to common questions.

Check out what's new in Medicare to help manage your overall health and wellness. Some changes to Medicare starting January 1, 2025 include:

- The maximum out-of-pocket cost for prescription medications will be capped at \$2,000 for the calendar year.
- A new option of spreading out-of-pocket drug costs across monthly payments throughout the year instead of when they happen.
- Better mental health care
- More resources for caregivers
- Changes to telehealth coverage

#### Allocation of Delegates for the Fourteenth International SOAR Conference

The 2025 International SOAR Conference is scheduled for Friday and Saturday, April 4-5, 2025, at the Caesars Forum Conference Center in Las Vegas, NV. Delegates will be arriving on April 3 and departing on August 6.

Chapters with over 200 dues-paying members according to our records as of September 1, 2024, are allocated the following number of delegates: (Elections to be held in November.)

- One delegate for each Chapter of 201 500 members
- Two delegates for each Chapter of 501 700 members
- Three delegates for each Chapter of 701 900 members
- Delegates shall increase at the above rate for Chapters of larger size

Chapters with less than 201 members are eligible to attend the Conference in one of the allocated "at-large" slots. The number of at-large delegates to each District shall be one for every 300 dues-paying members or a majority fraction thereof, after subtracting the membership numbers of the larger (201 or greater) chapters.

As outlined in our Rules of Procedure for the Nomination and Election of SOAR Conference Delegates (Appendix A), the process for electing "at-large" delegates can either be by an election at a district conference, or other method, determined by the SOAR Board Member and USW Director, for that geographical area and approved by the SOAR Executive Board. (See page 17 – Appendix A, Article III Section 2.)

In order to be elected a delegate to this conference, the member must be a member in good standing at the time of the election. As in the past, hotel, travel and a stipend will be provided for all approved delegates out of the District SOAR fund. All delegates will be sent an official call letter that outlines the procedure to make their air and hotel reservations well in advance of the conference.

Please contact your SOAR Executive Board Member to obtain information as to how your District will complete its at-large delegate election process. Their contact information is listed below.

#### APPENDIX A

#### SOAR CONFERENCE DELEGATES - NOMINATIONS AND ELECTIONS:

#### **RULES OF PROCEDURE**

As approved by the USW International Executive Board on December 13, 2022:

#### **ARTICLE I INTRODUCTION**

SCAR

**Section 1.** The SOAR By-laws, Article IX, provide that the current SOAR Officers and Executive Board members hold office until the International SOAR Conference, to be held in conjunction with the USW International Convention. The delegates to the SOAR Conference are to elect the new Officers and Executive Board members for a term of (3) years.

**Section 2.** The following procedures shall govern the nomination and election process for the delegates to the SOAR Conference.

Article VII, Section 2 of the SOAR By-laws as amended reads as follows:

"The District SOAR organizations shall consist of representatives from the geographic area covered by the corresponding District of the USW. The District Representatives shall be selected from the membership in each District. The District Representatives will constitute the delegates to the SOAR Conference. The number of District Representatives will be based upon the membership in each District in accordance with the procedures established by the SOAR Executive Board with the approval of the Executive Board of the USW."


#### ARTICLE II AUTOMATIC DELEGATES AND OBSERVERS

**Section 1.** SOAR Officers, Executive Board members and Coordinators (one (1) Coordinator, who is a SOAR member and not on the USW staff, per District selected by the USW District Director) shall be considered automatic delegates to the SOAR Conference. SOAR Coordinators who are not automatic delegates or who are not elected as District Representatives and SOAR Coordinators who are employed by the USW may attend the SOAR Conference as observers.

#### ARTICLE III ELECTION OF SOAR CONFERENCE DELEGATES

**Section 1.** SOAR Chapters with more than 200 dues paying members. These SOAR Chapters shall elect their allotted delegate(s) at their regularly scheduled chapter meeting six (6) months prior to the date the International Conference is to be held. If a SOAR Chapter does not have a regularly scheduled meeting in that month the election may be held in either the month before or the month after, upon notification of such variance to the District Executive Board Member. The SOAR in Action magazine shall contain information alerting the membership to the upcoming election of delegates in an issue to be published no later than seven (7) months prior to the date the International SOAR Conference is to be held.





#### Section 3. Allocation of Delegates.

SOUR

- (a) The number of delegates allotted to each District shall be one per every 300 dues paying members or a majority fraction thereof; provided that each District shall have at least one representative.
- (b) The number of delegates allotted to each SOAR Chapter of more than 200 members shall be as follows:

One delegate for each Chapter of 201 to 500 members

Two delegates for each Chapter of 501 to 700 members

Three delegates for each Chapter of 701 to 900 members

Delegates shall increase at the above rate for Chapters of larger size

The Director of SOAR shall furnish each SOAR Chapter with a report on their current membership and the number of delegate(s) they are eligible to elect at their SOAR Chapter meeting no later than seven (7) months prior to the date the International Conference is to be held.

**Section 4. Eligibility.** To be eligible to be elected as a SOAR Conference Delegate from a SOAR Chapter or as an At-large delegate a person must be a member in good standing.



**Director's Note:** The SOAR office sent updated membership lists to the SOAR chapter presidents and recording secretaries to confirm the number of dues-paying members (members in good standing) their chapter had as of September 1, 2024.

Per the rules of procedure outlined in Appendix A, the chapter's membership size on September 1, 2024, determined the chapter's allotment of delegates to the International SOAR Conference.

#### **SOAR Chapter Resolutions**

The Fourteenth International SOAR Conference will be held on Friday and Saturday, April 4-5, 2025.

All SOAR Chapter resolutions, to be considered by the International Conference, must be adopted by the Chapter and sent to the SOAR Director. They must be in the Director's hands no later than 60 days prior to the convening of the International Conference. (Next year all resolutions must be received in the SOAR office in Pittsburgh by February 3, 2025.) The SOAR Director shall submit all Chapter resolutions and any recommendations of the SOAR Executive Board to the Chairperson of the resolution committee.

Resolutions must be typewritten or word-processed on separate sheets of paper and only on one (1) side of the paper. In order for the resolution to be considered they must be signed by the Chapter President and the Recording Secretary.
