DIRECTOR'S REPORT

ftentimes our heroes don't wear capes or uniforms; they are average Joes, who fortunately happen to be in the right place at the right time.

Below is an incident that happened recently that demonstrates the importance of the Health and Safety trainings the Steelworkers (and the companies we work for) offer to all members. These trainings are not only a great asset to fellow members in and out of our work environments, but also to the general public in emergency situations they may encounter on and off their jobs. This training can and has made a significant impact and difference in the lives of others, especially to these two individuals in particular on this day.

On the morning of Feb. 2, Vinny Foxx, a member of Local 12004 from Eversource, was on his way to a service call when the SUV in front of him suddenly swerved across a lane of traffic and hit a utility pole.

Vinny immediately pulled over and found an older woman in the driver's seat of the vehicle. She was conscious but confused. Vinny maneuvered her out from behind the airbag and sat her down outside the vehicle to administer first aid. That's when he saw a man on the ground in front of the car who appeared to be badly injured.

Just down the street, Sean Tierney, who is another member of Local 12004, was on a separate service call, when he heard the crash.

"It was a loud bang, and I immediately rushed over," Sean said. "The first thing I saw was the Eversource van and then Vinny helping the driver. There was a bystander helping the pedestrian on the ground, so I immediately called 911."

Sean then aided, along with the bystander, in putting pressure on the injured man's face to slow the bleeding. They used the only materials they had available, a shirt and a hat, until police and emergency medical technicians arrived on site.

The company and union conduct "First Aid and Stop the Bleed" training, which definitely came into play in this incident. Both agreed the training teaches members to protect themselves, each other, and the public. Vinny and Sean used that training and their instincts to jump in when they had to.

Unfortunately, our members work in jobs where people can

get hurt or killed, so it never leaves the back of their minds.

The driver was taken to a local hospital with minor injuries. The pedestrian suffered serious injuries and was transported to a hospital in Boston.

Either one of these USW brothers could have easily driven around the accident as others may have done, but no, these brothers jumped right in and used their training. They care about those we serve in our area every day, which speaks volumes about their character, and their commitment to the community.

Gas Operations, in partnership with Gas Safety and the USW, are constantly upgrading trainings and tools when it comes to first aid and immediate emergency response. In 2022, the Stop the Bleed program was introduced into the annual first aid/CPR program for the gas business and recently a new program was implemented where AEDs were added to a portion of the gas operations fleet.

The USW and Local Union 12004, along with company management, are proud and honored in the Milford Sub-District to recognize the courage, knowledge, and ability to act quickly in tough situations these members demonstrated as a result of the ongoing training they receive.

Whether the safety training is by the USW, the company, or a collaborative effort, you never know when or where the circumstances will arise that you will need to utilize the knowledge you received from the training.

- A discussion from OSHA Area Director Jeff Prebish about the importance of organized labor in the fight for workplace health and safety.

- Dr. Michael Lax received a Lifetime Achievement Award.
 For more than 30 years, Dr. Lax has diagnosed and treated
 nearly 10,000 patients for work-related illnesses and
 injuries. His practice of medicine emphasizes worker/
 patient empowerment and is characterized by a profound
 commitment to his patients. Dr. Lax has changed the
 landscape of workers' health in upstate New York and
 beyond.
- Mickey Berger also received a Lifetime Achievement Award. Mickey was the Syracuse Sub-District Director until his retirement in 2000. He's still going strong, serving as president of the Central New York Chapter of SOAR.
- Ron Cady, known to most as "Captain Ron," is the
 President of USW Local 1438 at Twin Rivers Paper in
 Little Falls, N.Y. He received the Sub-District Appreciation
 Award for 2023 because of his willingness to lend a hand
 whenever called upon and for his many years of service
 and dedication to the members of the USW.

I would like to thank Local 318 President John Seckrettar, Vice President Brian Callow, Trustee Arturo Archila, and District 4 Staff Representative Luke Gordon, among those who worked tirelessly for a great period of time negotiating the first contract, keeping employees of Cascades informed as things developed in organizing, and supporting the team as needed.

Now that we're into spring, the Edison Sub-District is hitting the ground running, with a great emphasis on continuing

to train our local union officers, representatives, and stewards. We're expanding our outreach with shop steward trainings scheduled to take place in southern New Jersey and at the Sub-District office in Edison, as well as a recently-completed stewards training in the Delaware area, hosted by Local 0898. We're also continuing to offer health and safety training at the Sub-District office and recently hosted a two-day session on Accident Incident Investigations.

Finally, we recently concluded our annual Labor-Management sessions for local unions, and I'd like to thank all those members who attended throughout the Edison Sub-District.

USW VETERANS LAW SPREADS ACROSS THE COUNTRY

District 4 Rapid Response and the D4 Veterans Council are proud to report that the new Veterans Law ("An Act to amend the labor law, in relation to requiring employers to display a poster containing information on veterans benefits and services which shall be created and distributed by the department of labor,") that was passed in New York state is now being introduced in other states. In District 4 alone, the law has garnered support in Rhode Island, Maine, Massachusetts, and New Hampshire, and local legislators have introduced the bill in their State Houses. There are ten additional states where the bill is gathering support.

D4 LOCALS SHOW SUPPORT FOR VETERANS

Local 77M and Owens Corning out of Delmar, N.Y., held a 50/50 raffle to raise money for the Veterans Miracle Center in Colonie, N.Y. They collected more than \$3,000 in donations. In addition to the 50/50 (the winner donated his winnings back), Local 77M donated \$1,000 and the company matched their donation.

Members throughout District 4 contributed to our Warm Feet for Warriors clothing drive. We collected new winter clothing and donated it to the local VA hospital.

Members from Local 135 and 180 of Anchor Glass held their first Veterans of Steel Meeting in February. In attendance were Brian Pabis, Local 135 President; Harry Raymond, Local 180 Vice President; and Doug Frawley, Local 180 member. The meeting lasted about two and a half hours. Discussion included researching local veterans' services to see what they offer and visiting local veterans' museums. The group is also exploring options for hosting a benefit for Veterans and ways to get community involvement and more member participation.

VETS OF STEEL HONORED

At the District 4 Rapid Response Conference held in March, the Veterans of Steel were presented with a framed signed copy of the Veterans Law, which was signed into law by the Governor on November 10, 2022. District 4 Veterans of Steel Coordinator Cary Eldridge was honored to accept it on behalf of all Veterans in District 4.

"Getting this bill signed into law was most definitely a group effort," said Eldridge. "It was passed with the support of the USW Rapid Response Team as well as veterans and their supporters from around the District."

FLAG GIVEAWAY

The Veterans of Steel will hold their annual Memorial Day flag giveaway on May 23 at the New York State Fair Grounds in Syracuse, N.Y. Flags are given out for free to anyone who would like one, to honor and remember those who have made the ultimate sacrifice for our country.





RAPID RESPONSE

istrict 4 recently held a Rapid Response Conference and lobby day in Albany, N.Y. – the first since the COVID pandemic. The delegates heard from International Vice President Roxanne Brown, District 4 Director Del Vitale, Rapid Response National Director Amber Miller, New York State AFL-CIO President Mario Cilento, and District 4 Rapid Response Coordinator Mark McDonald, among others. After a day of addresses and training, the delegates went to the New York State Capitol, where they met with legislators to discuss the USW agenda for legislative action in 2023. The key priorities include improving the monthly benefit for sick or injured workers on workers' compensation, fighting against bans on natural gas hookups, making sure any carbon tax funds are returned to developing new jobs in our industries, and protecting our paper and forestry sector from unfair recycling funding requirements.
