t's been a busy few months since the last District 4 newsletter. A number of anti-worker, anti-union lawmakers in New Hampshire introduced misleadingly named "right-to-work" (RTW) bills in every legislative session.

These bills are designed to restrict our power at the bargaining table, leading to reduced wages and benefits. They're intended to put more money in the pockets of billionaires and corporations while forcing working people to fight over the scraps that are left over. A better name for this would be "right-to-beg."

This legislative session was no different. But with the hard work of USW members, we once again defeated this attack on our rights. Although our members led the way in this fight, we could not have done it alone. Over the many years we have been under attack, we have built a strong coalition with other labor unions, community leaders, grassroots community organizations, and laborfriendly Republicans in both houses of the Legislature.

This is a clear example of why we say all elections have consequences. Since the first time he ran, the governor said he would gladly sign this bill if it ever reached his desk.

During this fall's election cycle, we will work to support all of those who support the working people of New Hampshire. Party affiliation will not matter. If they are on our side, we will do all we can to ensure their reelection.

I am proud to say that District 4 has no RTW states. This is only because of our members, who show up at rallies, write letters, make phone calls, and attend town hall meetings to protect our rights.

Thank you to everyone who takes time to join this fight.

In March, Steve Finnigan, Mike Fisher, and I presented a donation to the GoGo Foundation, which supports a pediatric health care clinic in Ponce, Puerto Rico. This clinic provides free medical attention to community members.

Over the past several years, we built a strong relationship with the foundation and the community. We look forward to growing our presence in Ponce and expanding our ability to help those who live there through community service and organizing.

Over the course of several months, we collected donations from across the District. We took these donations and were able to make a sizable contribution, enabling the clinic to build and finish its emergency room.

Our members' generosity is overwhelming. Time and time again, when people are in need, our USW family steps up to make a difference. The donated money will help save lives in a city devastated by hurricanes and earthquakes.

# USW pushes for legislation to limit forced overtime in the Maine paper industry

District 4 staff representative John Perry recently met with a number of USW members and allies about LD 1794, an "act to enhance the predictability of mandated overtime in paper mills" in Maine.

John provided talking points to attendees so they could effectively educate their state representatives about this USW-led legislation. The bill would limit the amount of forced overtime, require 48-hour notice prior to forced overtime for known openings, and restrict a company from forcing someone to work during a pre-authorized vacation.

# USW Local Union 513 runs Food Drive

Members of Local 513 in Chicopee, Mass., held their first-ever food and toiletry drive recently. The local union officers worked with the management of Greif to encourage members to donate nonperishable foods, toothpaste, soap, deodorant and other toiletries.
